Conduct of Supplementary Exam for students of class IX and XI (2019-20)

With reference to the KVS(HQ) letter No. F.11029/16/2020/KVS(HQ)/Acad./Misc. Matters Dt. 03/07/2020 and instruction for KVS RO Guwahati, regarding the Conduct of Supplementary Exam for students of class IX and XI - it is to inform that all the Kendriya Vidyalaya AFS Borjhar will provide an opportunity for promotion to the next class to all the students of classes IX and XI who have failed in Annual Examination and placed for re-test, **on the basis of a project work to be submitted by those students in the subject /subjects in which the students were unable to score the minimum pass marks.**

For this, the concerned subject teachers have been instructed to assign outcome based good project work to all those students of Class IX and XI who are required to take the supplementary exams. **The topics would be from the curriculum of the respective classes and would have an element of inquiry, exploration, reasoning which may also include data collection and its interpretation.** The project works would aim at **assessing the understanding of the students of the concepts taught to them.** Students has been provided with about a week's time and asked to submit their project report online.

It may also be noted that the students should **complete the project independently and mention at the end of the project that "This project is done by me independently."**

The teachers concerned will be at liberty to talk to the students about their project work after the submission of the project report, if he/she feels so, while awarding the marks.

Needless to say, this one-time opportunity is being extended only in the current year in view of the unprecedented conditions of Covid -19.

Instruction for STUDENTS Appearing for Supple. Exam (Project Work)(IX& XI 2019-20):

1. All the concern subject teachers of IX & XI (SESSION 2019-20) have been instructed to inform the children about the methodology & mode of Project work by **06.07.2020**. Students are requested to take necessary guidance from the concern sub teachers.
2. Specific Project Work will be assigned to the children in different subjects by concerned subject teachers of respective classes IX & XI (2019-20) by 07.07.2020 through **Gsuit Google Classroom /whatsapp (whichever is convenient)**. **Students will acknowledge the receipt of the Assignment (Project Work) to concerned Teacher.**
3. All the concerned children (appearing in supplementary exam of project Work) will submit the project to the concerned teachers in **pdf form** through **Gsuit Google Classroom /whatsapp (whichever is convenient)** by **13.07.2020**.
4. **The Project Works should be Original and should not be copied from any other sources. Students will submit the Project Work as pdf saved file name as (class/sec_subject_name) e.g. IXC_ENGLISH_PARAMJEET KAUR**
5. Result of the Supplementary exam of IX & XI (Project Work) will be declared on **19.07.2020 (Tentatively) through vidyalaya website.**
